INVITATION FOR BIDS

Consulate General of India in Ho Chi Minh City invites Bids / Quotations from reputed agencies based in Ho Chi Minh City, Vietnam and background in dealing with supply, installation and maintenance of LED screens.

1. Notice Inviting Tender: Two-part sealed bids are hereby invited for “**SUPPLY AND INSTALLATION OF 01 LED SCREEN IN CONSULATE’S MULTI-PURPOSE HALL & ANNUAL MAINTENANCE FOR THREE YEARS INCLUDING THE FIRST YEAR AFTER INSTALLATION**”.

2. Eligibility criteria for bidders:

(i) The company should have at least 05 years' experience in dealing with the supply, installation and maintenance of LED screens.

(ii) The company should have valid permit / registration from a competent local authority in Ho Chi Minh City for supply of LED screens (A copy of English translation to be provided).

3. Bid system:- The two bid system (Technical & Financial) as detailed below should be followed for this tender:

(i) The bidder shall submit offer in **two separate seal envelopes**, namely (a) **First envelope** - superscripted as “Technical Bid – Supply and Installation of LED Screen” and (b) **Second envelope** – superscripted as “Financial Bid – Supply and Installation of LED Screen”. Both the sealed envelopes shall be kept inside a large sealed envelope i.e. in a **Third envelope** superscripted as “Tender Quotation for Supply and Installation of LED Screen”. It should also be superscripted at the bottom left corner with the Full name, Postal address, Fax, E-mail, Telephone number of the bidder; **First Envelope should also include a digital copy of the technical bid in PDF format.**

(ii) The sealed quotations shall be submitted to the office of the **Consulate General of India at 214, Vo Thi Sau Street, Vo Thi Sau Ward, District 3, Ho Chi Minh City.**

(iii) The bids may be submitted by Hand in person or by courier. The bids by 'Fax / E- mail' shall not be accepted.

(iv) Bids received after the closing date and time as prescribed in the tender notice, shall **NOT** be accepted under any circumstances. It is also requested to mention the completion time of the work in the bids.

(v) The bid has to be submitted as per the format specified at the Annexes with all the supporting documents. The bid is to be submitted in English.

(vi) Technical bid shall be opened on the date and time as given in the tender notice on the first page at the below address:

Consulate General of India at 214, Vo Thi Sau Street, Vo Thi Sau Ward, District 3, Ho Chi Minh City, in the presence of the authorized representatives of the companies, who may wish to attend.

(vii) Financial bid shall be opened on the date and time, to be communicated later, at Consulate General of India at 214, Vo Thi Sau Street, Vo Thi Sau Ward, District 3, Ho Chi Minh City, in the presence of the authorized representatives of the companies, who qualify the technical bids and wish to attend.

4. Pre-bid meeting: All bidders, if required, may visit the site of installation as the area has its specific requirements. Based on the area and seating arrangement of the site, a brief installation plan in English (no more than two pages) may also be provided in the technical bid. The pre-bid meeting will take place on **25 APRIL 2023 at 1100 hrs**. During the meeting, all bidders are welcome to clarify all their concerns regarding submission of technical and financial bid, if any.

Validity of Bids: The bids shall have a minimum validity of six months (**180 DAYS**) from the date of opening of bids. A bid for a shorter period of validity shall be rejected.

Payment terms: Payment terms shall be as below:

25% of the amount: Upon award of the Tender and signature of the Contract.

40% of the amount: Once Product is received.

25% of the amount: Upon Installation and Receipt of Completion certificate.

10% of the amount: Retention money to be released upon completion of one year of Guarantee/ Warranty period.

SCOPE OF WORK

The selected bidder shall be required to supply and install 01 LED Screen along with Video Controller and related accessories in the multi-purpose hall of the Consulate of India, Ho Chi Minh City. Technical parameters of the LED Screen are indicated at Annexure-I.
